- **★ No 4-H Class fees. 4-H Classes are for Archuleta County Members Only. No Stallions in 4-H Classes.**
- **4-H Awards:** Buckles will be awarded for high point in each age division and other awards will be given for reserve high point on down. Judge may provide feedback on all 4-H classes.
- ★ Open Awards: High point and reserve high point will be awarded in the open division. Ribbons will be awarded 1<sup>st</sup> through 6<sup>th</sup> place. Ties on High Point are determined by Showmanship score, if a tie still exists, a coin will be tossed.
- **★** Current Health Certificates and Brand Inspections will be required for 4-H members.
